

2025 Progress Update

The Greenpoint Petroleum Project is making good progress towards the completion of liquid product recovery, as can be seen on the annual recovery chart covering 2009-2025. We operate under the oversight of the New York State Department of Environmental Conservation (NYSDEC), with a strict focus on the protection of human health and the environment.

- We continue to operate the liquid product recovery system with excellent run-time performance above 90% and the product plume continues to shrink in area and thickness. We have gained NYSDEC approval to shut down wells that no longer recover significant amounts of product.
- Recovery well RW-23 met the criteria of the Recovery Well Shutdown Procedure and shutdown was approved by the NYSDEC. RW-23 was subsequently shut down and decommissioned in the second quarter of 2025.



- On-going soil vapor monitoring efforts continue, including sampling permanent soil vapor points both on and off site.
- On-going groundwater monitoring efforts continue, with sampling of monitoring wells both on and off site.
- On-going vapor enhanced recovery activities continue to enhance vapor and liquid product recovery at recovery wells located within Operable Units 5, 7, and 8.
- A renewed, modified State Pollutant Discharge Elimination System (SPDES) Permit was issued on March 12, 2025 and went into effect on April 1, 2025.
- On April 21, 2025, construction began on the consolidation of the two existing groundwater treatment systems into a single new facility which will process the groundwater extracted by all the operating recovery wells.

Dear Greenpoint Neighbors:

Welcome to the 18th issue of the Greenpoint Progress newsletter. ExxonMobil and our environmental contractor, Roux have been working hard to finish the liquid product recovery phase of the Greenpoint Remediation Project, and we are making good progress towards completion. As indicated in our progress update, liquid product recovery is decreasing as expected, and with approval from NYSDEC we have begun the process of shutting down liquid product recovery wells that are no longer productive. As we continue our work, we remain focused on the protection of human health and the environment.
