## Instructions

Owner Number: If your check is issued by XTO Energy Inc., your Owner number will have 8-digits and typically starts with

00[30\*\*\*\*\*\*\*] or 30\*\*\*\*\*\*. If your check is issued by Exxon Mobil Corporation, your Owner number will have 7-digits and may start

with any number. The Owner number can be found on your respective check statement.

Owner Name: Enter your complete legal name as it appears on your identification documents.

New Address: Enter your new address details, including street, city, state, and ZIP code.

Contact Information: Include your phone number and email address for any follow-up communication.

<u>TIN & SSN:</u> Please provide the last 4 digits of your TIN or social security number currently on file associated with the given owner number.

Name on Bank Account: Enter your complete name as it appears on your account.

Bank Name: Enter your bank's name.

<u>City and State:</u> Enter your bank's city and state. <u>Account Type:</u> Select which account type you have.

ABA Routing Number: Enter 9-digit number listed on the bottom of your check.

Account Number: Enter your bank account number.

<u>Signature:</u> Sign the form to confirm the information provided is accurate. For the owners' protection, direct deposit request may only be submitted by the actual owner or the owner's legally recognized agent (trustee, attorney-in-fact, etc.) IF YOU ARE ACTING AS AN AGENT, PLEASE ATTACH DOCUMENTATION VERIFYING YOUR RIGHT TO ACT AS AN AGENT ON BELHALF OF OWNER OF RECORD.

<u>Date:</u> Write the date when you are filling out the form.

## **Data Privacy Section**

We value your privacy and are committed to protecting your personal data. This notice explains how we collect, use, and protect your information when you submit a Direct Deposit Agreement form.

<u>Data Collection:</u> When you submit a Direct Deposit form, we collect the following personal data: Owner Number, Owner Name, Current Address, Contact Information, Last four digits of SSN, Signature

<u>Purpose of Data Collection:</u> We collect your personal data to update our records and ensure that all communications and deliveries are sent to your correct address in relation to your Owner Account.

<u>Data Usage:</u> Your personal data will be used solely for the purpose of updating your address and banking info in our system.

<u>Data Protection:</u> We implement appropriate technical and organizational measures to protect your personal data against unauthorized access, alteration, disclosure, or destruction. This includes compliance with international data protection regulations, such as the General Data Protection Regulation (GDPR) in the EU.

<u>Data Retention:</u> We will retain your personal data for as long as necessary to fulfill the purposes outlined in this notice or as required by law.

<u>International Data Transfers:</u> If your data is transferred outside your country of residence, we ensure that appropriate safeguards are in place to protect your data in accordance with applicable data protection laws.

Your Rights: You have the right to:

- Access your data
- Request correction of any inaccurate of incomplete data
- Request deletion of your personal data under certain conditions
- Object to the processing of your personal data
- Request the transfer of your data to another organization
