How to Submit an Invoice

Invoices must be sent to USAinvoice@exxonmobil.com. This e-mail is used only to receive invoices, other inquiries will **not** be monitored.

Important:

- Send only **one invoice** per e-mail. Any support documentation that you need to send with the invoice should be a separate file named **Attachment**.
- Invoice must not be encrypted or require a password to access. Special instructions submitted in the e-mail will not be monitored.
- Invoices must comply with the minimum invoice requirements described below. Invoices with missing or incorrect information **may be returned to the supplier**.
- When submitting invoices from purchase orders, it is recommended to submit a separate invoice for each purchase order to support fast and accurate payment processing.
- To submit invoices to ExxonMobil, you must have a vendor account. Please ask your ExxonMobil contact to ensure your account is created and up to date prior to submitting invoices.

Minimum Invoice Requirements:

- Invoice format:
 - Invoice must be in PDF machine readable document or TIFF file
 - Resolution 300 dpi
 - 1 invoice per PDF or TIFF file
 - 1 invoice per 1 e-mail
 - Invoice must not be encrypted or require password to access
 - Support documentation should be a separate file named Attachment.
 - E-mail cannot exceed 10MB
- Invoice details:
 - Document type title (e.g. invoice, credit note)
 - Invoice number
 - Invoice date
 - Invoice currency
 - Description of goods/services

- Purchase reference (PO #, SES #, or FSL #). If there is no PO number, you must provide the email address of the ExxonMobil business representative/client
 - Net amount (tax excluded)
 - Gross amount (tax included)
 - Tax rate(s) applied (f exempt or out of scope, please indicate)
 - Tax break-down per tax rate or exemption
 - Total tax amount
- Supplier details:
 - Your full company name
 - Your full company address
 - Electronic remittance information (Bank Account)
 - Bill must include:
 - ExxonMobil affiliate's full name (refer to the list below)
 - ExxonMobil company code (refer to list below)
 - ExxonMobil affiliate's full invoicing address

- **Company code (co code)**
(Include label Co Code XXXX number, referencing the purchasing company)
- **Company address**
